



## PERSONAL DATA PROTECTION POLICY FOR CCTV

Pursuant to the requirement under the Personal Data Protection Act B.E. 2562 (A.D. 2019), as may be amended from time to time, and any other applicable regulations issued by virtue thereof, we, Goodyear (Thailand) Public Company Limited (“**Goodyear**” or “**we**”) thus implement this Personal Data Protection Policy for CCTV (“**Policy**”) to provide you with information on the purposes for installing and operating the Close Circuit Television system (“**CCTV**”) on Goodyear’s offices and premises.

### Scope of this Policy

This Policy covers all individuals, including our staffs, employees, customers, potential customers, and any other members of the public entering Goodyear’s offices and/or premise.

### What does Goodyear Collect and Why?

We use CCTV on our offices and premises to monitor and record your images and videos, which are considered as personal data under the applicable personal data protection law (“**Personal Data**”), for the following purposes: (a) to prevent and detect commission of offence and crime; (b) to assist in potential investigation of suspected commission of offence and identification of offender; (c) to protect our personnel, assets, properties, offices, premises, as well as to ensure safety of yours and the public; and (d) to manage security by monitoring or controlling the entrance and exit of our office or premise.

### Disclosure of Your Personal Data

We may disclose your Personal Data to the members of our group companies and/or affiliates which may be located within or outside Thailand (which the country may or may not have sufficient level of personal data protection). In certain circumstances, we may be required by government agency, authority, court order or applicable law to disclose your Personal Data.

### Retention of Your Personal Data

We will retain your Personal Data for as long as necessary to achieve the purposes described in this Policy. However, in no event shall we retain your Personal Data longer than 60 days, unless otherwise required by applicable laws.

### Rights to Your Personal Data

Subject to conditions and limitations under applicable law, you are entitled to various rights to your Personal Data which are: (a) to have access to and obtain a copy of your Personal Data, and to request the disclosure of source of your Personal Data which you did not consent to; (b) to receive your Personal Data in a format which is generally readable and usable by automatic tool or equipment (if any) and to have your Personal Data in the said format transmitted to another data controller; (c) to request that your Personal Data be deleted, destroyed or de-identified; (d) to object to our processing of your Personal Data; (e) to request us to suspend the processing of your Personal Data; (f) to request that your Personal Data be corrected, updated or completed; and (g) to lodge complaints to the personal data protection supervisory authority.

### Changes to This Policy

We may amend, change, or update this Policy from time to time and to the extent permitted by laws. We will notify you about such amendment, change or update if there is significant change to this Policy.
